Special qualifications: Members must be at least eighteen years old, but do not need to be a resident of Oxnard; one member shall be a licensed architect, and one member shall own a business or property in the Central Business District Zone. All DDRC members are appointed by the City Council at large.

MOBILEHOME PARK RENT REVIEW BOARD (MPRRB)

The Board members are appointed to investigate, hold hearings on, and pass upon issues related to mobile home park rent stabilization; to make or conduct such independent hearings or investigations as may be appropriate; and to adjust maximum rents either upward or downward upon completion of their hearings and investigations. Meetings are held on an as-needed basis in the City Council Chambers.

Special Qualifications: Members shall be persons who are not connected with the real estate or rental housing industry for their financial gain; members shall not be residents of or have any financial interest in any mobile home or mobile home park. All MPRRB members are appointed by the City Council at large.
